**RULES & REGULATIONS**

1. Other tables may be moved into the pavilion area, however, if moved they must be returned to their original locations or there will be an additional Charge of \$20 for City Employees to do this.
2. Trash receptacles are located around each pavilion. It is the responsibility of the renter to pick up your trash.
3. All pavilions located at the Ovid Recreational Fields and at Gumaer Park have electrical outlets. If when you arrive there isn't any service, you may contact the Clinton County Central Dispatch at 911 and ask them to dispatch out the DPW Department to come and assist you.
4. No alcoholic beverages allowed on the premises.
5. No permit will be issued for more than one (1) year in advance.

6. No person, group or organization shall make or cause any changes, modifications, improvements, constructions or landscaping to the City Park or Recreational Fields without prior approval from the City of Ovid's Council.
7. Any Non-Profit Organization who can provide a Federal ID number will be Exempt from any charges required to reserve any of the pavilions located within the City of Ovid.
8. Renter shall not violate any federal, state, or City rules, regulations, laws, or policies. This requirement includes, but is not limited to, the City ensuring that all users of the Room will comply with the Center for Disease Control and Prevention's recommended social distancing and face-mask wearing measures during the rental period.
9. Renter agrees to indemnify and hold the city harmless from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of renter's use of city facilities and to reimburse the City for any such expenses incurred.
10. Moreover, by signing below, you agree to indemnify and hold harmless the City and its officials, employees, and volunteers, from and against all claims, damages, losses, and expenses, including reasonable attorney's fees, arising out of or resulting from your failure to ensure that users of the rented park or facility comply with the Center for Disease Control and Prevention's recommended social distancing and face-mask wearing measures, or a Michigan's Executive Order in effect at the time of use.
